# Information for traders

Please read carefully

All stalls must be booked in advance. Please complete the enclosed booking form and **compulsory Health and Safety Declaration** and return them with the total amount owing by **Wednesday 21<sup>st</sup> June 2017**. Please do not leave it until the last minute!

## STALL SECURITY

Please continue to be vigilant with your stall security. We strongly advise you all, to keep your money on your person at all times and to keep valuable stock in a secure manner. Overnight security is provided so that stalls can be fully set up on Saturday. The show ground will have 24-hour security from 9am on Saturday 1<sup>st</sup> July to 10am on Monday 3<sup>rd</sup> July 2017.

## SETTING-UP TIMES

These are Saturday afternoon 1pm – 5.30pm (last entry 5pm) Sunday morning 8am – 10am. Vehicle passes must be displayed on the windscreen, to gain entry to the showground.

## WRISTBANDS

These will be issued with your booking. These are your free personal passes for stallholders and their staff only, and must be worn on Sunday. The number of free wristbands will be limited to two per pitch. This means that if, for instance,

you book two pitches, you will be entitled to four wristbands. Any extra people will be charged for admission at the stallholders' rate of €10 each, which can be paid in advance with your booking.

## PARKING

Stallholders vehicles will be directed to the allocated parking area. They cannot be parked in the show ground due to space restrictions unless the vehicle is on the pitch you are working from. Pitch area in the trader's village will be eight metres long by five metres deep, and are in blocks of five long by five deep with two walkways. That is, along hedge line one row then a walkway, then two pitches back to back, then a walkway with two more pitches back to back.

This, where possible, should be located under the sale tables, to give a clean appearance to the auto jumble.
